- PROFIT:** You shall earn 40% of your total *pre-taxed* sales. Profit shall be taken upfront. Balance, including any applicable sales tax and shipping charges, shall be submitted to your authorized Tupperware Rep with your fundraising orders.
- SHIPPING:** You shall receive free shipping when your total pre-taxed sales reach \$400. You will be assessed a low 7% shipping fee if your total sales are under \$400.
- CANCELLATION FEE:** In the event you should need to cancel your fundraising event after your fundraising kit has been received, you shall be subject to a \$75 materials and handling fee. Canceled fundraisers are defined as fundraisers which produce zero sales, or fundraisers in which orders and payments are not submitted to your Authorized Tupperware Fundraising Rep within 30 days of your fundraiser end date above.
- PAYMENTS:** Your organization shall be responsible for collecting payments for orders and submitting one payment to us for all orders. You shall retain your profit upfront and submit the balance to us at the time you submit the fundraising orders. To calculate your profit, tally the product totals before tax is added and multiply by .40. This is your profit. Send the difference by cashier's check or postal money order payable to your Authorized Tupperware Fundraising Rep. A personal or organization check is permitted but will delay order processing by 7-10 days.
- DELIVERY:** Your estimated product delivery date is 3-4 weeks from the time we receive your orders.
- PRODUCT AVAILABILITY:** Occasionally items from our fundraising line will become unavailable. In the event this should occur during your fundraising event, your customer shall receive a substitute product of equal or greater value.
- REFUND POLICY:** Tupperware does not offer refunds on fundraising orders. All sales are final unless the product is replaceable under the terms of our lifetime warranty (see #10 below).
- LOCAL CONSULTANT ASSIGNMENT:** Your Authorized Tupperware Fundraising Rep does not work in partnership with your local Tupperware Consultant. Should you choose to utilize the assistance of a local consultant after we have shipped your fundraising materials, you will be assessed a \$75 materials and handling fee.
- LIABILITY:** Tupperware is not liable for the results of your fundraiser as each fundraiser is unique and the results vary depending on the effort made by your individual participants.
- WARRANTY:** In the event that a product arrives in damaged condition or becomes chipped, cracked, peeled, or broken, we will offer a free replacement. All products manufactured by Tupperware are backed by our lifetime warranty.
